Selection Procedure:

- Candidates will have to appear for written exam (35 question of 2 marks each = 70) (Qualifying marks 50% of total marks i.e= 35)
- Candidates qualifying in written exam will be allowed to appear for Computer eligibility test (10 marks) & interview (20 marks) on the date to be fixed and notified.
- Candidate who will secure highest marks (combined written, Computer eligibility test & interview) will be selected for the post. Merit list will be displayed.
